3. For the year 2025, the Scheme aims to recognize the contribution of civil servants under the following categories:-

- i. **Category 1: Holistic Development of Districts under 11 priority sector programmes. 5 awards would be conferred under this category.**
- ii. **Category 2: Aspirational Blocks Programme- 5 awards would be conferred under this category**
- iii. **Category 3: Innovations for Central Ministries/Departments, States, Districts. 6 awards would be conferred under this category.**

4. The web-portal for registration and submission of applications for the PM's Awards 2025 (www.pmawards.gov.in) is proposed to be launched on **02nd October, 2025**.

5. As you may further be aware, the Central Ministries/Departments can submit their nominations for the Innovations category under the Prime Minister's Awards. Multiple nominations can be submitted by a Ministry/Department.

6. The Scheme for the Prime Minister's Awards is being notified on an earlier date to give the Ministries/Departments ample time for collection of data and documentary evidences with respect to their concerned Innovative practices.
